This course is an introduction to theory and techniques for treating emotional and psychological disorders in children and adolescents. Content will promote an understanding of the various counseling approaches to treatment and treatment evaluation. Permission of the instructor required.

9. Justification should include: A. Academic rationale and goals for the course (skills or level of knowledge students can be expected to attain).	
Trends in the field of counseling suggest an increased need for applied skills in providing services for children and adolescents. Counselors are increasingly asked to provide direct counseling services to children and adolescents. Therefore, counselors need to be more proficient in advanced developmental theory, as well as specific counseling strategies and techniques intended for this population. This course is intended to provide both theoretical and practical knowledge about development as it relates to therapeutic assessment and counseling strategies for working with children and adolescents.	
B. How does the course fit with the mission established by the department for the curriculum? If course is mandated by an accrediting or certifying agency, include the directive. The Department of Psychology and Counseling trains professional counselors and psychological service providers for work in a broad array of settings (e.g., P-12 schools, postsecondary institutions, community mental health agencies, rehabilitation agencies,	

psychiatric hospitals, residential treatment facilities, and private practice). Practitioners in all these settings are better able to meet the needs of their clientele if they understand the counseling approaches to treating children and adolescents with psychological and emotional disorders. The proposed course adds to the curriculum related to several accreditation standards (CACREP Core Curriculum: II.K.2.c, II.K.2.d, II.K.3.a., II.K.5.b.; CACREP Mental Health Specialty Curriculum C.5.; CACREP School Counseling Specialty Curriculum C.2.a, C.2.d, C.2.g, and C.2.h.; CORE Standard C.2, C. 3, C. 5, and C. 7. (as it applies to Children and Adolescents).

C. Student population served.

This course can serve the needs of students in all graduate programs in the Department of Psychology and Counseling as an elective. In addition, this course could be appropriate for current professionals in the field seeking a better understanding of how to proficiently counsel children and adolescents.

D. Rationale for the level of the course (lower, upper, or graduate).

The proposed course should be offered at the graduate level due to its content and purposes. This class can serve students currently in graduate level counseling and psychology programs and post-graduate practitioners.

Counseling Children and Adolescents with Emotional and Behavioral Disorders (i.e. ADHD, ODD, Conduct Disorder)
Systems Interventions for the Family
Multicultural Considerations to Counseling Diverse Youth

Week Five:

Counseling Children with Special Needs (i.e. Learning Disabilities, Physical Disabilities, Gifted)
Adolescents with Substance Abuse Issues
Adolescents with Eating Disorders

11. Course Requirements

Exams

Midterm & Final - Both exams will be multiple choice and comprehensive essay type questions.

Papers and Projects

Students will write a 10-page research paper analyzing a current issue or topic (family violence, delinquency, alcoholism, anxiety, etc.) related to counseling children and adolescents. Students must fully analyze the issue in terms of developmental considerations, symptoms, behavior, cognition, multicultural considerations, as well as provide appropriate intervention strategies based upon age of the client. Students must have appropriate research to support the issue/topic of the paper. Students must also address specialized community resources that can assist in addressing these issues.

Students will also do a presentation based on their research paper and offered for discussion and feedback. Students will be asked to provide to the class a handout so that each student will have resources on a variety of issues. Students will be required to turn in a copy of all research articles, paper, and handout at the time of presentation.

12. Special features (e.g. labs, exhibits, site visitations, etc.)

The Assessment and Interventions portions of the course will include an experiential component, which will require students to engage in role-plays with the focus on developing both assessment and intervention skills. In-depth discussions of role-plays and specific feedback concerning skills will be provided to the student.
